Re: U.S. hemp farmers and rebuilding the economy

Dear Mr. President,

Thank you for the tremendous job in leading our nation and especially for your work to support farmers, including the 2018 Farm Bill that legalized commercial hemp farming once again.

We write to share our deep sense of commitment to playing a role in rebuilding the economy post-COVID-19. As you've often mentioned, the U.S. economy was the strongest it had ever been before the pandemic struck. The undersigned U.S. hemp producers stand ready to help rebuild our nation's economy and make it even stronger.

The domestic hemp production industry is barely 1 year old, and the projected numbers on what our nascent industry can produce are impressive. Domestic hemp production was not allowed until 2014 and then operated under limited pilot programs. The 2018 U.S. Farm Bill fully legalized commercial hemp production, thus, our contribution to the economy has yet to be realized.

As of January 2020, 47 states have hemp production programs and there were more than 17,000 licensed hemp producers during the 2019 growing season. U.S. domestic hemp production has increased dramatically since the passage of the 2018 Farm Bill: 25.5k acres in 2017<sup>1</sup>; 78k acres in 2018; and 511,442 acres in 2019. The hemp crop has thousands of end-uses from fiber and textile to food and healthy lifestyle products. According to the Hemp Business Journal, U.S. sales of hemp products reached \$820 million in 2018 and are projected to reach \$2.6 billion by 2022.

There are still market uncertainties for our nascent industry and it is critical to open end markets for our crops. The Administration could play a crucial role by resolving the regulatory barrier created by FDA that has prevented FDA from recognizing cannabidiol (CBD) as a legitimate botanical ingredient for use in food and dietary supplement products. Any support for a legislative solution in removing this regulatory burden would be sincerely appreciated.
